## APPLICATION BY PARENT OR GUARDIAN FOR A JUNIOR MEMBERSHIP

Dear Parent / Guardian,

In accordance with the Child Protection Act, We Epsom Angling Society have taken up some of the policies drawn up by the NFA, who working with the Child Protection Agency, NSPCC & Sport England have advised on certain guidelines.

You will note that on obtaining membership for a junior, there are rules which must be adhered to, these rules are in place to protect our fisheries, wildlife and the environment in which we fish. The key to getting this right is if in doubt don't do it wait and ask advice from a Bailiff.

Please complete these questions to ensure your child's safety on Epsom's waters.

Does the junior require any long-term medication for any illness? ( this will not impede the application but we need to be aware for the juniors safety )

Juniors under the age of 16 should not be left on Society's waters without adult supervision.

Please enclose a passport size photo of the junior with the application, the membership card must be carried at all times whilst fishing.

The gates on locked waters are to remain closed and locked at all times.

The taking of cans and tins onto Society waters is prohibited as is glass jars and bottles. Most importantly TAKE YOUR LITTER HOME WITH YOU this includes discarded fishing line and anything else you have brought to the water. Failure to comply with the Society's rules could result in confiscation of membership card.

Membership fee for Juniors under 16 £10.00 and must be accompanied by a  fully paid up Adult (Parent or Guardian) member.
